

ABOUT VFEX

The Victoria Falls Stock Exchange (VFEX), is a subsidiary of the Zimbabwe Stock Exchange established to kick start the Offshore Financial Services Centre (OFSC) earmarked for the special economic zone in Victoria Falls.

KEY MARKET HIGHLIGHTS

- The VFEX recorded a total turnover of USD3.2 million during the 2nd quarter of 2022 representing a 39.39% drop from the 1st quarter of 2022. Comparing the same period in 2021, the VFEX turnover for the 2nd Quarter of 2022 rallied by 10,911%. On a YTD basis the total VFEX turnover stood at USD8.5 million
- The VFEX All-Share Index rose by 7.72% from the 1st quarter of 2022 to close the 2nd quarter at 115.39 points. The VFEX All Share Index started in July 2021 hence there was no comparison for the same period in 2021.
- The VFEX market capitalization was 7.72% up from the 1st Quarter of 2022 to end the 2nd quarter at USD273.2 million.
 Comparing the same period in 2021, the market capitalization increased by 348%.
- The foreign participation on the VFEX was 38.13% during the 2nd quarter of 2022 registering a 35.5% jump from the previous quarter.
- The number of listings remained the same between 1st and the 2nd quarter of 2022. However, for the same period in 2021, the number of listed companies went up 300%.

The number of listed companies on VFEX as at 30 June 2022 was 4 (SeedCo International Limited (SCIL.VX), Bindura Nickel Corporation Limited (BIND.VX), Padenga Holdings Limited (PHL.VX) and Caledonia Mining Corporation Plc (CMCL.VX).






TURNOVER

- The VFEX recorded a total turnover of USD3.2 million during the 2nd quarter of 2022 representing a 39.39% drop from the 1st quarter 2022.
